PRESS RELEASE

On 7/15/2019 at 3:54 AM, Sgt. Palmer of the Red Oak Police Department was on routine patrol in the 100 block of Paradise Way and located a white male subject rummaging through a vehicle parked in front of a residence with another vehicle parked nearby containing a female passenger. Upon further investigation, it was determined that the male subject had burglarized multiple (UNLOCKED) vehicles with the assistance of the female subject throughout the City of Red Oak. The male and female subject were taken into custody for multiple counts of burglary of a vehicle based on the investigation.

Each subject was booked and secured into a cell without incident. Each subject has been identified below with their applicable charges and booking photos.

Based on the physical evidence recovered from the suspect's vehicle, it appears that multiple burglary of (UNLOCKED) vehicles were committed by the subjects in the City of Red Oak, City of Ovilla, City of Glenn Heights and potentially several other North Texas Cities.
