



**NOTICE OF PUBLIC HEARING ON

NOTICE IS HEREBY GIVEN TO ALL INTERESTED PERSONS, THAT:

The City of Red Oak, Texas proposes to institute annexation proceedings to enlarge and extend the boundary limits of said city to include the following described territory, to wit:

THE PROPOSED ANNEXATION OF 55 TRACTS OF LAND, GENERALLY DESCRIBED AS ANNEXATION TRACT "A", TRACT "B" AND TRACT "C" AND CONSISTING OF A TOTAL OF 204.7 ACRES, MORE OR LESS:

TRACT "A": GENERALLY COMPRISING OF APPROXIMATELY 46.06 ACRES SITUATED IN THE H. P. CRUM SURVEY, ABSTRACT NO. 208, AND THE R. CROW SURVEY, ABSTRACT NO. 199, ELLIS COUNTY, TEXAS AND BEING THOSE 25 PARCELS OF LAND NORTH OF F.M. 664 (OVILLA ROAD), EAST OF PRATT AND WEST OF BATCHLER ROAD:

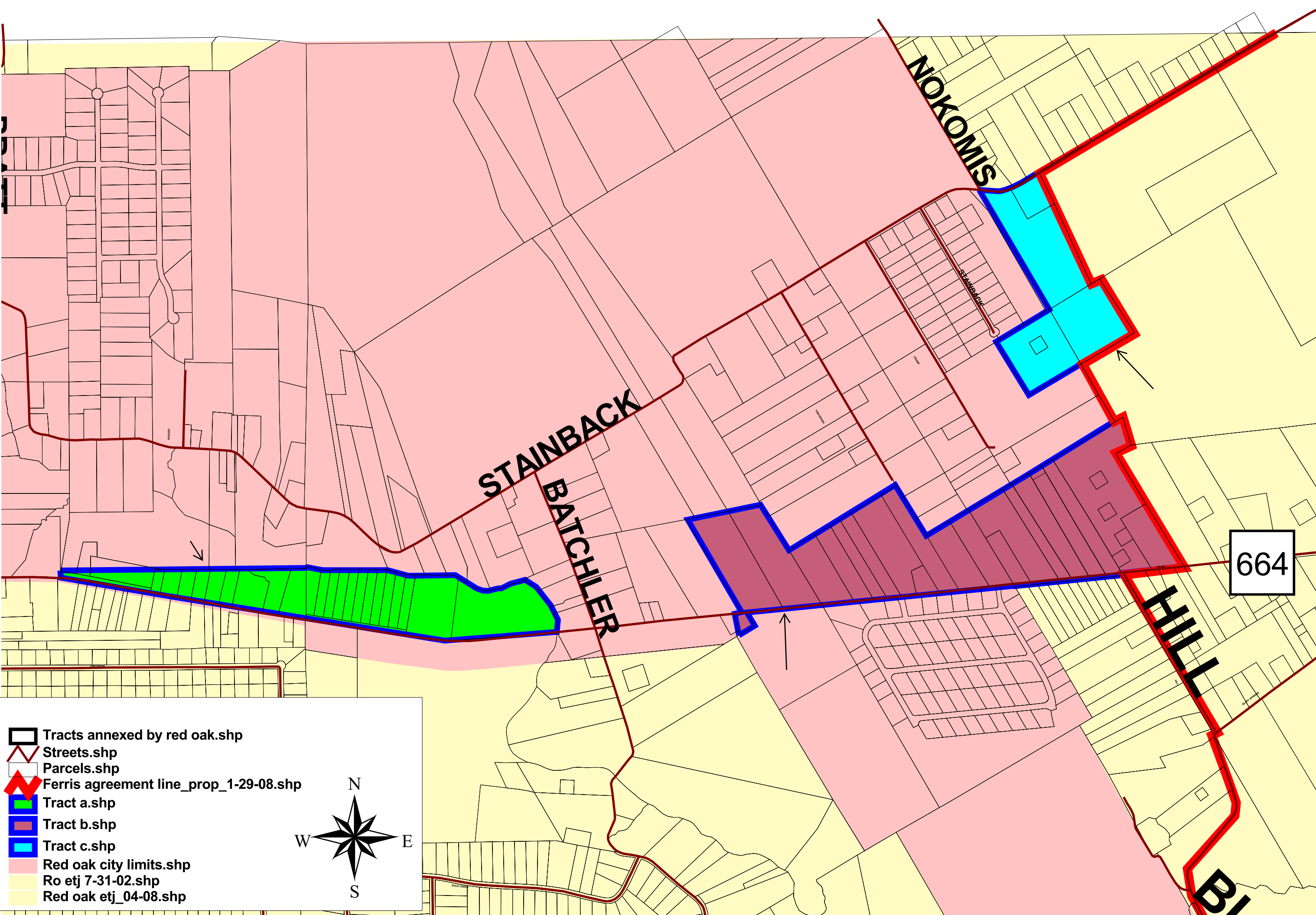
TRACT "B": GENERALLY COMPRISING OF APPROXIMATELY 119.9 ACRES SITUATED IN THE R. CROW SURVEY, ABSTRACT NUMBER 199 ELLIS COUNTY, TEXAS AND BEING THOSE 24 PARCELS OF LAND NORTH OF F.M. 664(OVILLA ROAD), EAST OF BATCHLER ROAD AND WEST OF THE RED OAK – FERRIS MUTUAL BOUNDARY LINE, AND INCLUDING THE FULL 120-FOOT WIDE RIGHT OF WAY OF F.M. 664 (OVILLA ROAD)

TRACT "C": GENERALLY COMPRISING OF APPROXIMATELY 38.75 ACRES SITUATED IN THE R. CROW SURVEY, ABSTRACT NUMBER 199 and the R. MORGAN SURVEY, ABSTRACT 694, ELLIS COUNTY, TEXAS AND BEING THOSE 5 PARCELS OF LAND IMMEDIATELY SOUTH OF STAINBACK ROAD AND WEST OF THE RED OAK –FERRIS MUTUAL BOUNDARY LINE

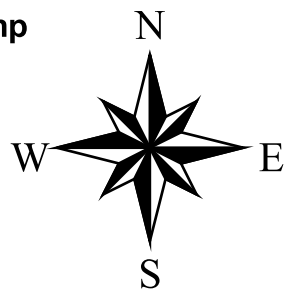
