A Regular Meeting of the Red Oak City Council was held via teleconference on Monday, January 11, 2021, at 7:00 p.m., with the following members present, to wit:

This is an open meeting conducted partially by telephone conference, however, there will be no public access to the physical location.

All departmental reports were submitted to Council and addressed individually as needed. Mayor Stanfill asked the Directors to present anything significant if needed.

Fire Chief Blanton spoke and updated Council on COVID-19 statistics, information and total expenses to date, for city, county, state and U.S. He stated that there were a few house fires at the end of December. He stated they are currently interviewing for three vacant positions.

Police Chief Wolf spoke and stated that he had no further updates, but was available for questions.

City Engineer Hartman spoke and updated Council on all the new homes coming into Red Oak, stating that 2020 was a good year for growth in Red Oak. There was a record number of new home permits issued totaling 337 for the year.

Human Resources Director Monsivais spoke and stated that she had no further updates, but was available for questions.

Finance Director Platt spoke and stated we are on track with the collection of property taxes. She also stated that sales tax is still trending up. She then answered Council's questions.

IT Director Binford spoke and stated he's working with the finance department on their new Incode server. He has now run fiber out to the new concession stand for communications, cameras and Wi-Fi. He is in the process of setting up Microsoft teams for the police department.

Library Director Ragsdale was experiencing technical difficulties and was unable to be heard.

Parks and Recreation Director Kelley spoke and highlighted activities and projects given in his monthly report. He thanked the public works and information technology departments for their help with the Live Oak project construction.

Public Works Director Williams spoke and stated that the department just wrapped up the grease and fats collection from Thanksgiving through Christmas holidays and collected 175 gallons of grease and fats for proper disposal.
