CALL TO ORDER: *The Mayor will call the meeting to order, declare a quorum, if present, and declare notices legally posted pursuant to Open Meetings Act.*


COUNCIL BUSINESS – REGULAR SESSION:

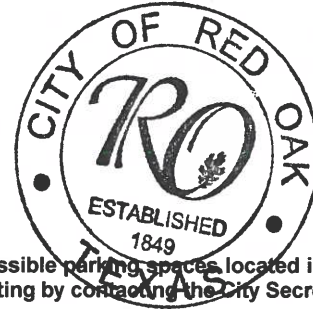
