PERMIT CONDITIONS:

1. A person shall obtain an excavation permit from the director of Public Works or the Right-of-Way (ROW) Manager prior to performing any excavation, construction, relocation, removal, installation, repair, or maintenance of facilities within the right-of-way. A permit is required for new construction and replacement or upgrading of a utility provider's network in the right-of-way, either aerial or underground.
2. All contractors must be registered with the City of Red Oak Public Works Department and listed on the permit.
3. No line locates will be provided without an approved permit.
4. All Contractors must comply with all state and local traffic regulations, O.S.H.A., and other applicable safety codes, and assume all related liability. Localized traffic issues and traffic plans must be approved by the ROW Manager and submitted with this ROW permit for acceptance. All required permits must be attached to this request.
5. Contractor shall be responsible for the protection, replacement, or relocation of trees and existing ground cover disturbed. Contractor must restore work site/area to existing condition or better (i.e. landscaping, lawn, any irrigation and erosion control if damaged or removed).
6. Contractor shall notify ROW Manager at least 24 hours prior to construction. In case of emergency after normal working hours, notify the Red Oak emergency dispatch at 972-775-3333.
7. All construction shall comply with City of Red Oak Construction Standards. A meeting discussing these standards may be required or scheduled by request to the ROW Manager.
8. All work requiring an inspection shall be done between 8:00 am and 5:00 pm. Monday through Friday, except on Holidays. **No work shall be performed on Holidays.** A right-of-way user may work on Saturday subject to the approval of the ROW Manager and a notification no later than noon on Thursday before the Saturday in which the work is to be performed. The Saturday inspection fee must be paid prior to noon on Thursday prior to the Saturday in which the work is to be performed. Upon completion of construction, schedule an appointment with the ROW Manager for a final inspection.
9. **Allow up to 10 days for permit review after all permit information has been received.**
10. The use of "missiles" is not approved construction method for tunneling, and may ***NOT*** be used in any City ROW, Easement, Franchise UE, city-engineered or approved HOA or green scape area unless ROW Manager gives prior written approval.
11. All excavation within **City right-of-way or future right-of-way requires mechanical compaction** equal to adjacent undisturbed materials. **To meet the requirements set by the North Texas Council of Government specifications for construction, compact the backfill to a density of 95%. (Sec. 13.06.11 [3])**
12. No digging will be allowed within one foot of pavement without prior approval from ROW Manager.
13. Minimum depth of cover for all bores shall be 36" under street, 24" under other pavement, from bottom of pavement structure to the top of bore or deeper if required clearing other utilities. Unauthorized or approved bores shall be flowable cement filled and abandoned in place.
14. Applicant shall be responsible for securing all easements and other permits that are either indicated or may be required for this project.
15. **Notification of intent to all affected residents/builders is required by signage and door hangers 48 hours before any site work may be started.**
16. This permit and accompanying construction plans shall remain at the job site at all times.
