## PRESS RELEASE

On 9/15/2018 at 4:40 hours, Red Oak Police Department personnel were dispatched to CVS located at 105 Harris in regards to an aggravated robbery that just occurred. The Northern Ellis Emergency Dispatch Center dispatcher advised officers that the reporting person indicated that a black male subject entered the store, produced a black semi-automatic weapon and requested the money from the register. The reporting person complied and the suspect fled the business. Sgt. Esquibel arrived, secured the scene and examined the surveillance video of the offense. Sgt. Esquibel observed the suspect to be a black male subject wearing a tan ball cap, black t-shirt with a design on the front and back, blue jeans with tears in them and was carrying a brown and tan bag. Sgt. Esquibel broadcasted the description of the suspect over the police radio and Red Oak Police Officer Dustin Bragg advised that he had just stopped a gray in color Ford Five Hundred vehicle for no license plate light containing the suspect as a passenger. Officer Bragg further advised that the vehicle was showing to be stolen out of the City of Dalworthington Gardens on 9/14/18. The vehicle was confirmed as stolen and Officer Bragg and Officer Pettit subsequently took the female subject into custody for stolen vehicle. The female driver was identified as Kidd, Cassandra W/F 39 YOA of Dallas, Texas. The male passenger was detained and was identified as Hunt, Jerry B/M 32 YOA of San Antonio, Texas. Upon further investigation, the money and weapon were recovered and Hunt was taken into custody for the aggravated robbery. Kidd was taken into custody for assisting in the aggravated robbery along with the unauthorized use of a vehicle. Both subjects were transported to the Red Oak Police Department for the offenses until they could be arraigned. Hunt was subsequently arraigned and is being held on a \$250,000 Bond for the Aggravated Robbery while Kidd was arraigned and is being held on a \$250,000 Bond for the Aggravated Robbery and a \$20,000 Bond for Unauthorized Use of a Vehicle.
